Google Fiber's High Speed Internet and Television expansion into the Northland has arrived and it is time for Gladstone residents to sign up. Carriage Hills 7-9 joins Carriage Hills 1-6, Carriage Crossing and Brooktree Homes in making up an area called a "Fiberhood". What exactly is Google Fiber?

Google Fiber brings a 1 Gigabit internet connection to your home. How fast is that? Right now the fastest speed Time Warner offers in our area is 50 megabits and AT&T U-Verse's top speed is 18 megabits. Google Fiber is 1000 megabits! That's 20 times faster than Time Warner and more than 50 times faster than AT&T.

Google Fiber also has a TV plan that includes a selection of channels comparable to other cable or satellite providers. Check out their channel lineup here:

Google Fiber has 3 plans available:

- 1. Gigabit Internet: \$70 month
- 2. Gigabit Internet + TV: \$120/month (includes a free Google Nexus 7 tablet)
- 3. Basic internet (5 Megabits): Free for 7 years with a \$300 install fee



## **ANNUAL CRIME REPORT FROM GLADSTONE PUBLIC SAFETY**

Gladstone Public Safety Crime Analyst Dick Cunneen and Officer Kelly Kirk gave an overview of the past 14-15 months of crime in our neighborhood. Overall, we live in a very safe area with a low crime rate. Almost all reported thefts in the area were from vehicles, and nearly all of those were from unlocked vehicles with valuables left in plain sight. All of the assaults in our area were domestic violence cases. There were a few cases of destruction of property, caused by BB guns and pellet guns. There were also some violations of door-to-door sales ordinances.

Residents were reminded to lock their vehicles and not leave valuable items in plain view. We were reminded that door-to-door sales requires a license in Gladstone (except for school and Scout fundraisers). We were encouraged to call in any suspicious behavior, any time we were in doubt. Officer Cunneen stated that all calls received about suspicious persons or vehicles have been reasonable calls. We are doing a good job of calling things in and are encouraged to continue.

Officer Cunneen also reminded us that, when something happens, it only counts in the analysis if we make a report. "Just letting them know" does not count. He said that if we meet any resistance from any officer when we ask to make a report, we should let him know at (816) 423-4034.

#### ANNUAL MEETING ELECTION RESULTS

At the Annual Meeting, twenty-one homes were represented in person and four were represented via proxy. A quorum was met and elections were held. The results of the election follow:

- The two by law changes were passed unanimously. (1) remove verbiage regarding interim board of directors; 2) require two signatures for checks over \$2,000.
- Two current board members were re-elected: Torance Fisher and JoAnn Fisher
- Two new board members were elected to join the board: Don Ward and Melanie Scott.

## **NOTES FROM THE ANNUAL MEETING**

Several issues mentioned at the Annual Meeting are affecting the esthetics of the neighborhood and making it look not-so-nice. The specific examples brought up at the meeting include:

- 1) Leaving newspapers on the driveways, yards, or streets. It was suggested that if you do not want the papers, you might be able to unsubscribe to some of them. For example, the Gladstone Dispatch can be stopped by calling (816) 454-9660. To stop the Kansas City Star publications, call (877) 962-7827. In any case, please pick up any papers that are on your property and dispose of in the trash if you do not want them.
- 2) Trash Bins are unsightly when setting in front of homes or garages. In fact, Gladstone has an ordinance against leaving trash bins and trash bags in front of homes and garages. Please find an appropriate place to store your trash bin. The ordinance is Title IX Building and Construction Ordinance, Chapter 1000 Property Maintenance Regulations, Section 308.5 Storage and screening of trash containers. The ordinance states: All containers and bags used for the purpose of disposing *rubbish* and *garbage* shall be stored no closer to the public streets than the front building line; for corner lots all containers shall be stored no closer to the public streets than the front building line and side building line adjacent to the street of any premises. In either case, no container or bag shall be stored in front of the main building and/or attached garage; in addition corner lots shall not have containers stored on the side of the main building and/or attached garage adjacent to the street. **Exception**: On the day of scheduled pickup, during which contained *rubbish* and *garbage* may be temporarily placed near the public street for the purpose of pickup. The Home Association Board was asked to send letters to home owners who are in violation of this ordinance and request that they move their trash bin to an appropriate place on their property to comply with the ordinance.

In addition, we had other issues mentioned. These include:

- 1) Concern for joggers running in the streets which presents a safety hazard to the joggers.
- 2) We also had people concerned about the snow on sidewalks.

We learned from Gladstone Public Safety that there are no ordinances against either of these activities and they are not addressed in our covenants. Gladstone Public Safety recommended that joggers use the trails that have been created for runners and bikers for their own safety. Joggers explained that the reason they do not run on the sidewalks is because the hard surface of sidewalks creates shin splints and other health issues for runners. It was recommended that if joggers do run on the streets, they wear reflective clothing and also run on the side of the street toward traffic so they can see cars coming. As far as shoveling snow from sidewalks, this is a dilemma because shoveling could cause health issues to the people doing the shoveling especially in extremely cold weather and not shoveling causes safety issues for children walking to bus stops. This year is hopefully an exception as far as the number of snow storms. Hopefully, in future years, this will not be as much of an issue.
