GLADSTONE-FREE SPRING BRUSH DISPOSAL EVENT

DATE: Friday, Saturday, & Sunday, May 5th, 6th, and 7th TIME: 8:00 a.m.—5:00 p.m.

PLACE: Public Works Facility, 4000 NE 76th Street (North of Happy Rock Park)

All brush and yard waste will be accepted. We cannot accept processed wood, trash, or hazardous waste at this event. Proof of residency is required All bags much be emptied. This event is open to Gladstone residents only. All others may use our weekday service.

GLADSTONE-SPRING CLEAN-UP EVENT (BEAUTIFICATION)

DATE: Friday, Saturday, & Sunday, April 28th, 29th & April 30th

TIME: 8:00 a.m.—5:00 p.m.

PLACE: Happy Rock Park (NE 76th St. & N. Antioch) Residential trash and debris will be accepted at no charge to Gladstone Residents. Appliances will be accepted with a charge for any appliance that uses Freon. There will also be a Fee for tire disposal. \$5.00 for tires, \$10 for tires on a rim, and \$15 for oversized tires. No liquids, hazardous waste, or brush/yard waste will be accepted. Proof of residency is required.

Things you need to know!

- The Disposal Facility is located at Gladstone Public Works, 4000 NE 76th Street. This is north of Happy Rock Park at N. Antioch Road & NE 76th St.
- Proof of residency must be presented in the office at the time of payment. We accept cash or check only.
- All landscape companies are welcome to use the facility.
- If you have a truck and trailer, you must pay the fee for both.
- You may bring yard waste in bags, however you must empty them to show that they do not contain trash. Paper bags may be left on site, Plastic bags must be taken with you.
- Stumps and tree trunks will be charged at a rate of at least double the load price.

ARCHITECTURAL FORMS

There were a lot of new roofs installed over the past few months in our neighborhood and our Architectural Control Committee has been diligent in following up with home owners to obtain the necessary paperwork. As a reminder, if you are planning to have a roof replaced or other home improvement <u>GET APPROVAL</u> <u>BEFORE WORK STARTS TO AVOID COSTLY ISSUES</u> - completing the form and obtaining approval is required. It is not optional! Our Architectural Control process protects our neighborhood from becoming non-compliant with our covenants and supports our desire to maintain property value.
