CARRIAGE HILL 7-9 COVENANT CHANGES

The Carriage Hill 7-9 Home Association Board appointed a committee to consolidate, review, and update the association covenants. When our homes were originally built, the developer filed separate covenants for Plat 7, Plat 8, and Plat 9. There are some differences between the restrictions in the documents which makes it confusing. Many home owners are not sure of their plat and the architectural control committee had three separate set of restrictions to enforce. The Association Board hired an attorney to work with the committee to consolidate the three documents into one set of covenants and modify a few restrictions. As you recall, the changes to the restrictions were discussed at the Annual Meeting in March and have been posted on the association website for your review. The covenants have been finalized and we are now at a point where we need to gather 75% approval from home owners in each plat to record the new set of covenants with the recorder of deeds. This approval will be in the form of a notarized signature of all homeowners as listed on the title deed for each home. The association has a team of notary publics who will be assisting in the process of obtaining official signatures from home owners.

A series of signing meetings are scheduled to allow questions or concerns to be addressed and to obtain the required signatures from home owners. If homes are owned by both husband and wife or two joint owners, both are required to sign and show their approval of the changes to the covenants.

You will receive a copy of the proposed covenants to review, and a schedule of dates/times/places to meet, ask questions, express concerns, and/or sign your approval form. A government issued photo ID will be required for the notarized signature. Remember, if multiple people are listed in county records, all homeowners must sign the signature page/approval form.
